**MEMORANDUM OF COOPERATION (MOC)
BETWEEN THE UNIVERSITY OF ISFAHAN, I. R. IRAN
AND
THE AL-AMEER FOUNDATION FOR STUDIES AND RESEARCH, R. IRAQ**

According to the regulations in force in each of the countries concerned, the two parties agreed with the following articles:

Article 1. Student admission

- 1-1- Al-Ameer Foundation for Studies and Research agrees to send the candidates who want to continue their studies at different levels to the University of Isfahan.
- 1-2- The University of Isfahan agrees to hold the doctoral and master classes in English for those whose English proficiency is approved by Al-Ameer Foundation for Studies and Research.
- 1-3- The University of Isfahan agrees to open master classes with at least 4 and doctoral classes with at least 2 students for the candidates introduced by Al-Ameer Foundation for Studies and Research.
- 1-4- For research-based programs, the University of Isfahan agrees to hold the required courses intensively. The courses and the time the courses to be held are determined based on the agreement between the students and their supervisors.
- 1-5- The University of Isfahan agrees to assist and to cooperate with Al-Ameer Foundation for Studies and Research to hold Persian learning courses for the candidates who need to learn Persian to continue their studies at the University of Isfahan by for example holding training workshops for its Persian instructors and providing them with course and lesson plans.
- 1-6- The University of Isfahan also agrees to offer high quality Persian training courses to the students from the Al-Ameer Foundation for Studies and Research and apply the maximum discounts to tuition and accommodation fees during the Persian training period.
- 1-7- Tuition and accommodation fees will be received according to the regulations of the University of Isfahan.
- 1-8- Tuition and accommodation fees will be subject to an annual increase.

Article 2. General considerations

- 2-1. Any changes, modifications and amendments to this MOC should be done based on mutual consent and agreement and will be effective from the time the changes, modifications and amendments are made.

- 2-2. Neither party may assign any article of this MOC, whether partially or wholly to a third party.
- 2-3. The protection of intellectual property rights shall be enforced in conformity with the laws and regulations of the two countries.
- 2-4. The signing of this MOC does not imply any kind of financial commitment for either institution.
- 2-5. The students introduced by Al-Ameer Foundation for Studies and Research are obliged to observe the regulations of the University of Isfahan.
- 2-6. The parties agree to solve in a friendly manner any controversy arising from the interpretation of the present agreement. In the event that the disagreement cannot be resolved, the issue(s) will be submitted for arbitration; each party will appoint a member of the arbitration panel and an additional member will be chosen by mutual consent.
- 2-7. In order to ensure the good management of this MOC, each party will appoint a person within it to be in charge of the day-to-day operation of this program.
- 2-8. This MOC shall be effective for 5 years from the date of signing and shall be subject to change, renewal and termination by mutual consent. A party may terminate this MOC for convenience and at any time and for any reason by giving six months' notice in writing to the other party.
- 2-9. The termination of this MOC shall not affect the implementation of the activities that have been undertaken prior to such termination, unless agreement is achieved in this regard.
- 2-10. This MOC shall be construed and governed in accordance with the laws of two countries and the regulations of both institutions.
